

## **Terms and Conditions**

By entering this Competition, you agree to the below Terms and Conditions:

### **ARTICLE 1: Objective of the Competition**

1.1 The Competition is organized by UN Women BiH. The Competition is part of the UN Women global initiative Generation Equality. The Competition shall promote gender equality and challenging stereotypes in BiH society. More precisely, the Competition invites young people to advocate for equal opportunities for all genders, to break down barriers for women's participation in all aspects of society, and to contribute to the broader conversation about shifting social norms and promoting greater equality and inclusivity in society.

Competition centers around these topics:

(1) Redefining or rewriting gender roles, (2) Breaking stereotypes and embracing equality, (3) Shifting social norms in gender roles, (4) Challenging stereotypes in media representation, (5) Addressing toxic masculinity and promoting healthy expressions of masculinity, (6) Promoting gender-neutral language and inclusivity in communication, (7) Promoting gender equality in the workplace, (8) Encouraging men to embrace caregiving roles, (9) Empowering women in traditionally male-dominated industries, (10) Breaking down barriers to women's political participation.

1.2 All entries to the Competition must be inspired by ten topics, as referred to above. Entries deviating from the above shall be automatically disqualified. The Area of Concern addressed in the artwork must be specified in the entry form.

### **ARTICLE 2: Terms of participation**

2.1 To enter the Competition, you must upload your artform via [Google Form](#).

Only those entries uploaded via the designated Google Form will be accepted. Entry is free.

2.2 You may enter one art form and you can only enter your art once.

2.3 You must enter your art form by midnight (CET) 16 June 2024. Late entries will not be accepted. Due to the expected high volume of last-minute entries, we advise you to make your submission well in advance of the entry deadline.

2.4 Together with the submission, you must submit a completed entry form providing your name, year of birth, address (e-mail), phone number, country of residence, short description of the work, and the topic addressed in the art form.

2.5 Ten finalists will be selected by a judging panel of at least five members. The decisions of the jury are final and binding.

2.6 All finalists will be notified via e-mail after the judging is complete. If you receive a notification e-mail from UN Women BiH, you must respond to the notification e-mail to accept your prize. If UN Women BiH does not receive a response from you within seven days

of the notification, UN Women reserves the right to reallocate the prize to another participant.

2.7 Names of the finalists will be officially announced by the end of June 2024.

The prize for the three finalists will be:

- **First Prize:** Smartphone Samsung Galaxy S24 (980 \$)
- **Second Prize:** Smartphone Samsung Galaxy S23 (800 \$)
- **Third Prize:** Smartphone Samsung Galaxy A55 (520 \$)
- **Fourth Prize:** Smartphone stabilizer DJI Osmo Mobile 6 (250 \$)
- **Fifth Prize:** External HDD Disc 2 TB (100 \$)
- **Five prizes from 6<sup>th</sup> to 10<sup>th</sup> place:** Tracer Led Ring (55 \$)

**Total value of prizes: 2.925 \$**

Prizes are non-transferrable.

The finalists' arts will be exhibited virtually or in situ (depending on the situation) during the award ceremony and the next Generation Equality event in BiH.

The finalists' first and last name(s) will be available with their art forms and displayed under their respective arts at the exhibition. By entering this Competition, every candidate provides his or her consent to the disclosure of his or her first and last name(s) as contemplated in this paragraph.

2.8 The Organizing Entities reserve the right to cancel, modify, suspend, or delay the Competition in case of unforeseen circumstances beyond their reasonable control. UN Women reserves the right to change, amend, delete or add to these Terms and Conditions at any time.

2.9 The Organizing Entities and their officials and agents shall not be responsible or liable for any claims, demands, losses and liability of any kind or nature arising out of or in connection with your participation in this Competition or your acceptance or use of the prizes awarded.

### **ARTICLE 3: Eligibility of participants and artworks**

#### **3.1 Eligibility of participants**

3.1.1 You must be between 18 and 35 years old as of 16 June 2024. You must provide your year of birth in the entry form.

3.1.2 You must use your legal name and provide valid contact details along with your art form.

#### **3.2 Eligibility of submitted artform**

3.2.1 The digital format of the submitted artform must be in .jpg, .jpeg, .png, or .pdf formats (static) or .gif, .mp4, .mov, .avi, .wmv or similar (animated) formats.

3.2.2 Your artform must not be in the determination of the Organizing Entities:

- be disrespectful of the impartiality and independence of the United Nations;
- reflect adversely on the Organizing Entities;
- be incompatible with the aims and objectives of the Organizing Entities;
- be derogatory to any persons depicted in the artform;
- contain any nudity, lewd, or otherwise offensive or inappropriate content.

The Organizing Entities shall not be responsible or liable for: a) any problem, loss or damage due to delay and/or failure in receiving and sending the entry as a result of any network, communication or system interruption or error, or b) any error, interruption, deletion, defect, delay in operation or transmission, site failure or unauthorized access to entries.

3.2.3 The submitted art form must be an original, unpublished work. Entrants represent and warrant that their Submission is their original work, it has not been copied from others, and it does not violate the rights of any other person or entity.

3.2.4 Incomplete entries or entries that do not comply with these Terms and Conditions will be automatically disqualified at the sole discretion of the Organizing Entities.

#### **ARTICLE 4: Copyright**

4.1 All Competition entries become the property of the Organizing Entities and will not be acknowledged or returned. The copyright in any submitted art form shall remain the property of the entrant, but entry in this Competition constitutes entrant's irrevocable, perpetual permission and consent to the Organizing Entities and others authorized by the Organizing Entities without further compensation or attribution, to use, distribute, reproduce or otherwise utilize the submitted art form in whole or in part, and the entrant's name and city and state, by any means or methods now known or hereafter devised in any and all media now in existence or hereinafter created, throughout the world, for the duration of the copyright in the art form. The entrant also consents to the Organizing Entities doing (or omitting to do) any acts in respect of the submitted art form which may otherwise constitute an infringement of the entrant's moral rights. Organizing Entities and/or others authorized by the Organizing Entities shall have the right to edit, adapt, and modify the submitted art form.

#### **ARTICLE 5: Indemnification**

5.1 By entering in the Competition you agree to indemnify, defend, and hold and save harmless, the Organizing Entities, and its officials, agents, employees, consultants, sub-contractors and other representatives from and against all suits, proceedings, claims,

demands, losses and liability of any kind or nature brought by any third party against Organizing Entities, including, but not limited to, all litigation costs and expenses, attorney's fees, settlement payments and damages, based on, arising from, or relating to the Organizing Entities' use of the submitted artform. The obligations under this section do not lapse upon closure of the Competition.
