Sevlid Hurtić (Doboj, 1970) graduated from the Faculty of Economics, and in 2015 he earned a master's degree in management. That same year, he enrolled in doctoral studies and obtained his PhD in 2019.

In the 2016 local elections, he was elected as a councilor in the City Assembly of Doboj, and he retained his seat in the subsequent 2020 elections. From 2021 to 2022, he served as the President of the Doboj City Assembly and as the coordinator for Bosniak issues on behalf of the City of Doboj.

In the 2022 general elections, as part of the coalition "Movement for the State," he was elected as a member of the National Assembly of Republika Srpska. He also served as the Minister of Trade and Tourism in the Government of Republika Srpska. He is the founder and president of the political party BiH Greens.

Pramila Patten, Special Representative of the Secretary-General on Sexual Violence in Conflict

Under-Secretary-General Pramila Patten was appointed as the United Nations Special Representative of the Secretary-General on Sexual Violence in Conflict on 12 April 2017. Prior to this appointment and since 2003, Ms. Patten served as a member of the Committee on the Elimination of all Forms of Discrimination against Women (CEDAW). She was the Chairperson of the Working Group on General Recommendation No. 30 on "Women in Conflict Prevention, Conflict and Post-Conflict situations". She has been a member of several High-Level Panels and Projects, including the High-Level Advisory Group for the Global Study on the Implementation of UN Security Council resolution 1325 (2000) on Women, Peace and Security, and the Advisory Panel for the African Women's Rights Observatory (AWRO) within the United Nations Economic Commission for Africa (ECA). She previously was a Commissioner of the International Commission of Inquiry into the massacre in Guinea Conakry on 28 September 2009. A national of Mauritius, she has been a practicing lawyer since 1982 and a member of the Honourable Society of Gray's Inn.

Awa Dabo is a human rights lawyer with extensive experience in crisis recovery, peace building, transitional justice, humanitarian affairs, and development. Awa has held several positions within the United Nations, including currently as Director and Deputy Head of the Peacebuilding Support Office (PBSO) at the UN Department of Political and Peacebuilding Affairs.

Awa was previously Chief of Country Oversight and Support for the UNDP Regional Bureau for Africa, Senior Advisor and Head of the Crisis and Fragility Policy and Engagement team for the Crisis Bureau of UNDP, Country Director for UNDP in Tanzania, and Regional Programme Manager and Team Leader with UNDP's Bureau for Crisis Prevention and Recovery.

Awa has experience both at HQ and at country offices, having worked in Africa, Asia, Latin America and the Caribbean, and Europe. During her professional career, Awa has worked with other UN and non-UN entities including the UN Office for the Coordination of Humanitarian Affairs (OCHA), the Office of the UN High Commissioner for Human Rights (OHCHR), the UN Department for Peacekeeping Operations (UN DPKO, now DPO) and the African Society of International and Comparative law, an international law NGO based in London.

Awa holds an LLM in International Human Rights Law from the University of Nottingham and a BA in Law, Sociology and Social Anthropology from the University of Keele.

Nyaradzai Gumbonzvanda, Deputy Executive Director for Normative Support, UN System Coordination and Programme Results

Ms. Nyaradzayi Gumbonzvanda (Zimbabwe) assumed her duties as UN Assistant Secretary-General and UN Women Deputy Executive Director for Normative Support, UN System Coordination, and Programme Results on 6 February 2024.

Ms. Gumbonzvanda brings more than 35 years of experience in the fields of development, human rights, peace and security, high-level advocacy, civil society engagement, and policy influencing and development, with a focus on women's empowerment, gender equality, and women's and children's rights. Her personal experience growing up in resource-poor and war-ravaged communities drives her passion to ensure that all women and girls, and their families, fully enjoy their rights.

Before her current position, she served as Founder and Chief Executive of Rozaria Memorial Trust, an organization founded in memory of her mother, which has supported girls and women in Zimbabwean rural communities since 2007 through innovative initiatives that promote education, health, and entrepreneurship.

Ms. Gumbonzvanda was appointed the first African Union (AU) Goodwill Ambassador on Ending Child Marriage (2014-2022). In this capacity, she engaged with Heads of State and other high-level officials, civil society, and youth, to advocate for progressive and rights-based continental positions on women's and girls' issues, paving the way for the development of the AU Convention on Violence against Women and Girls in 2023.

Prior to that, she was General Secretary of the World Young Women's Christian Association (YWCA) between 2007 and 2016, Regional Director in the East and Horn of Africa for the United Nations Development Fund for Women (UNIFEM, now part of UN Women) between 2001 and 2007, and Human Rights Officer in Liberia and National Child Rights Adviser in Zimbabwe for the United Nations Children's Fund (UNICEF) between 1998 and 2001. Previously, she served as the Interim Coordinator for the Zimbabwean Women Lawyers Association and as Assistant Law Officer at the Ministry of Justice, Legal and Constitutional Affairs of Zimbabwe.

Ms. Gumbonzvanda was awarded a Doctor of Laws degree (Honoris Causa) by the University of Massachusetts, United States, and holds a Master in Laws from the University of South Africa, a Post Graduate Certificate in Conflict Transformation from Uppsala University in Sweden, and a Bachelor of Laws, Honors Degree, from the University of Zimbabwe.




Ajna Jusić, Founder and President of the Forgotten Children of War, Bosnia and Herzegovina

Ajna Jusić, a psychologist and activist from Sarajevo, Bosnia and Herzegovina, is dedicated to advocating for the rights of marginalized groups worldwide. Since founding the "Forgotten Children of War" Association in 2016, she has served as its president, leading efforts for the social and legal recognition of children born of conflict-related sexual violence, as well as those whose fathers were members of UN peacekeeping forces and humanitarian organizations. A major milestone was achieved in 2022 when the world's first law recognizing the special rights of children born of wartime sexual violence was adopted, ensuring the protection of their fundamental human rights. In addition to her activism, Ajna is actively engaged in research and advocacy on social justice and gender equality. She is the co-author of the internationally recognized exhibition "Breaking Free" and the author of the publication "Dealing with Restlessness and Peacebuilding from the Perspective of a Post-Dayton Woman". Her expertise includes strategic advocacy, impactful research, and effective leadership, contributing meaningfully to human rights and social change at both national and international levels.

Mary Lawlor, United Nations Special Rapporteur on Human Rights Defenders

Mary Lawlor from Dublin, Ireland, has worked with human rights defenders for over twenty years, and has been engaged in human rights work for double that. She became a Board member of the Irish Section of Amnesty International in 1975, was elected Chair from 1983 – 1987, and became its Director in 1988. She founded Front Line Defenders in 2001 to focus specifically on the protection of human rights defenders at risk. As Executive Director from 2001-2016, Mary had a key role in the development of Front Line Defenders into the prominent international organization it is today. On 1 May 2020, she took up the mandate of the Special Rapporteur on the situation of human rights defenders, where she has adopted a people-centred approach to the mandate. Mary is also currently an Adjunct Professor of Business and Human Rights in the Centre for Social Innovation (CSI), School of Business, Trinity College Dublin, and has been awarded Honorary Doctorates in Law from University College Dublin and Trinity College Dublin. She is a member of the Advisory Board of both the School of Business of Trinity and the Centre for Ethics in Public Life, School of Philosophy, University College Dublin.

Rosa Emilia Salamanca, Executive Director of Corporación de Investigación y Acción Social y Económica (CIASE), Colombia

Rosa Emilia Salamanca is a Colombian feminist and peacebuilder, also a wife, mother, and grandmother. Her professional background is in anthropology, human rights, and indigenous perspectives. She has years of experience dedicated to the pursuit of sustainable peace in Colombia, contributing to this process through collective initiatives, such as the Summit of Women and Peace, shaping both its social and institutional construction. Her work was fundamental to the Final Peace Accord between the Colombian Government and the FARC-EP, which has been recognized globally for its gender focus. She is part of networks and bodies that emerged from this accord, like the National Security Guarantees Commission. Currently, she is the head of the Social and Economic Research and Action Association (CIASE). Today her work largely centers on security from a feminist perspective and the implementation of peace agreements, especially regarding sustainability and territorial economic recovery. She considers herself an activist researcher, believing the work we produce must be instrumental in bringing about the changes our societies deserve.

Sara Cook, Director of Cook Consultancy and conflict response specialist, Northern Ireland/USA

Sara Cook is a Belfast-based conflict response specialist with extensive experience working with people affected by conflict in Northern Ireland and internationally. Her peace building work includes mediation, dialogue and storytelling encounters between conflict-affected populations, including victims and survivors of violence, security forces and paramilitaries. Much of her work addresses the psychosocial impact of conflict, including the impact of mediation and peacebuilding work on practitioners. For over 20 years, Sara has designed and implemented methodologies to address conflict-related impact and provides training and facilitation in mediation, dialogue, trauma intervention and resiliency. She has trained people from over 50 countries, including humanitarian aid workers supporting the resettlement of war refugees from Ukraine, Syria, and Afghanistan. The Women, Peace and Security Agenda is a key priority in Sara's peacebuilding work, and she has recently published research on reducing barriers to participation through addressing the psychosocial needs of women mediators and peacebuilders. She is the UK representative to Women Mediators Across the Commonwealth and was a lecturer and field director for the Conflict Transformation Certificate Program at St. Mary's University.

Randa Siniora, General Director of the Women's Center for Legal Aid and Counselling (WCLAC), Palestine

Randa Siniora is the General Director of the Women's Center for Legal Aid and Counselling (WCLAC) and has been a leading feminist and human rights defender for over 38 years. She holds an LLM in International Human Rights Law from the University of Essex (UK) and an MA in Sociology-Anthropology from the American University in Cairo.

Randa made history in 2018 by becoming the first Palestinian woman from civil society to brief the UN Security Council on the situation of Palestinian women under occupation during the Women, Peace and Security Open Day.

She currently serves as Co-Convener on the Steering Group of the Arab CSOs and Feminists Network and was recently selected by UN Women to serve on the Generation Equality Multi-Stakeholder Leadership Group (2022–2025), representing civil society organizations on behalf of WCLAC.

Randa's lifelong work centers on advocating for justice, equality, and the protection of women's rights in contexts of prolonged conflict and occupation, making her a key voice in both regional and international gender equality and human rights efforts.

Radmila Žigić, Director of Foundation Lara Bijeljina, Bosnia and Herzegovina

Radmila Žigić (Brčko, 1960) graduated from the Faculty of Political Sciences in Belgrade in 1984, with a degree in Journalism. She has over 25 years of experience working in the media. As a long-term activist and director of the Foundation "Lara," she has dedicated her efforts to advocating for women's rights. Since 1998, Radmila has led initiatives aimed at protecting women from domestic violence. In 2011, she founded a safe house for women and children victims of domestic violence in the Bijeljina area and surrounding cities. She initiated the research project "Women in the History of Semberija" (2010–2018), resulting in three published books and an exhibition highlighting the fight for women's rights and emancipation, representing a significant contribution to documenting women's history in Bosnia and Herzegovina. Since 2014, she has served as the coordinator of the women's peace movement "Peace with a Woman's Face," which unites 14 women's human rights organizations. The movement develops actions and policies aimed at increasing women's security in Bosnia and Herzegovina, including integrating gender considerations into transitional justice processes. Radmila is also the author and editor of numerous publications and research works. She resides and works in Bijeljina.

She headed and established the Tolerance and Non-Discrimination Department with the OSCE Office for Democratic Institutions and Human Rights and served as Chief of Party of the Canadian Governance Support Office in Afghanistan. She has led more than 15 global, regional and country-level strategic reviews and evaluations for a range of UN entities including UNFPA, UNDP, IOM, and UN Women in Asia-Pacific, Europe and Central Asia aimed at strengthening performance and increasing the impact of the UN system. Introductory Reflection: Sopio Rusetski, Head of Gender Department, Public Defender's Office of Georgia

Sopio Rusetski is a dedicated expert with 18 years of experience working on issues of gender equality, violence against women, and domestic violence. She spent ten years working in the Office of the Public Defender of Georgia, during which she authored three publications on implementing the National Action Plan of UN Security Council Resolution 1325 on "Women, Peace, and Security," providing recommendations for government agencies and producing other thematic reports. For the past four years, she has been leading the Gender Department, actively contributing to policy development and the protection of women's rights. As a trainer, she provides education on topics such as gender equality, violence against women, early marriage, femicide, and human security. She is a member of the Inter-Agency Commission on Gender Equality, Violence Against Women, and Domestic Violence, serving in the working groups on "Women, Peace, and Security" and "Early Marriage and Other Harmful Practices." Additionally, she participates in the femicide working group at the Parliament of Georgia, further advocating for women's rights and safety.

Karine Sujayan is a seasoned Armenian diplomat and expert in international human rights and humanitarian law. She currently serves as the Head of the Department for Human Rights and Humanitarian Issues at the Ministry of Foreign Affairs of Armenia, a position she has held since 2019. Her diplomatic career spans over three decades, including postings as Deputy Permanent Representative to the Council of Europe in Strasbourg and First Secretary at the Armenian Embassy in Poland. Ms. Sujayan has been a driving force behind Armenia's engagement with international organizations on human rights issues, having led related divisions at the Ministry of Foreign Affairs across multiple terms since the early 2000s. She holds the diplomatic rank of Envoy Extraordinary and Minister Plenipotentiary. She is the author of the book Armenia: Human Rights – Domestic Context and International Politics, and has published over 50 articles on human rights, diplomacy, and international cooperation. A graduate of Yerevan State University in Philology and Journalism, she has also undertaken specialized human rights training in Finland, Poland, Switzerland, the U.S., and Egypt.

Ministry of Defence of North Macedonia

Lieutenant Colonel Strašo Stojčevski received his education at the Army Military Academy in Belgrade and the Command Staff College at Skopje, North Macedonia. Commissioned into the Army of the Republic of North Macedonia in 1992, he commanded Signal Platoon from 1992-1993 and Signal Company from 1993-1996; was Deputy Battalion Commander and Battalion Commander from 1996 to 2000; and was Head of G-6 from 2000 to 2003. He held the appointment of Adviser for bilateral cooperation in the Ministry of Defense before becoming staff officer in NATO JFC HQ Brunssum 2009-2013. He was appointed as Adviser for NATO-led operations and exercises in 2013. He is a certified Gender Trainer since 2014, planning, conducting and evaluating gender perspective related training events in the Ministry of Defense of the Republic of North Macedonia and Army of the Republic of North Macedonia, as well as instructor and syndicate leader at courses around the region and Europe (Serbia, Georgia, United Kingdom, Croatia). He graduated from the Gender Field Adviser Course 2015 at the Nordic Centre for Gender in Military Operations. He works on the implementation of previous and the new National Action Plan of the Republic of North Macedonia for implementation of UNSCR 1325.

Dafina Peci has served as the Executive Director of the National Youth Congress of Albania since 2016. She holds a Bachelor's degree in Political Science and International Relations and a Master of Science in Regional Politics and Security. In addition, she completed postgraduate training focused on post-conflict security, peacebuilding, and mediation institutions.

Since 2017, Dafina has also been academically engaged as an Assistant Professor at the Department of Political Science, Faculty of Social Sciences, University of Tirana.

One of the most significant milestones in her career in the field of youth and peacebuilding was her role in the Working Group for the establishment of the Regional Youth Cooperation Office (RYCO), where she served as one of Albania's two state representatives. Through her work, Dafina has been a strong advocate for youth participation, regional cooperation, and peacebuilding, contributing to policy development and institutional frameworks that promote youth empowerment and interethnic dialogue in the Western Balkans.

Introductory reflection: **Branka Antić Štauber**, President of Association "Snaga žene", Bosnia and Herzegovina

Prim. Dr. Branka Antić Štauber from Tuzla graduated in 1982 from the Medical Faculty in Tuzla. She is a specialist in infectious diseases and a family doctor. She is one of the founders of the "Snaga žene" (Woman's Strength) Association, where she is currently the president, and she also works as a physician. Since the founding of the association, she has been engaged as a doctor in the prevention and monitoring of chronic and infectious diseases in displaced persons' settlements in the Tuzla Canton. Since 2001, she has been actively involved in monitoring the first returnees to the Srebrenica region. She was awarded the Federal Cross of Merit - a deserved recognition for her decades-long engagement with survivors of sexual violence during the war in Bosnia and Herzegovina in 2025 at the German Embassy in Sarajevo. She is a co-author of two significant books on Helicobacter pylori and a collaborator with the medical magazine Acta Medica Saliniana. As a doctor, since 1997 she has been working in the private clinic Medica in Tuzla. She has received awards for her contributions to the development of the municipality of Tuzla and for achievements in improving and protecting the human environment, preserving cultural and natural surroundings, and significant contributions in health, culture, education, science, sports, as well as humanitarian and other charitable activities. She was also awarded the "Unusual European Woman" award at the Prix Europa radio festival in Berlin.

Biljana Stepanov is a senior expert in the prevention of gender-based violence, human security, and women's rights, with over 20 years of experience in civil society development, legal reform, and policy advocacy. As Director of the Center for Support of Women in Serbia, she has led numerous national and international projects focused on improving institutional responses to violence against women, developing victim-centered services, and promoting multisectoral collaboration. Her work is rooted in a human security framework, with a particular emphasis on improving the criminal justice response to gender-based violence and femicide, especially in cases involving firearms. She has provided expert support in developing investigative protocols, training curricula, and policy recommendations to prevent firearm misuse in domestic violence. She has received advanced training in gender equality and human rights from Cambridge University, the OSCE Leadership and Management Programme, and the Women's Human Rights Training Institute (WHRTI). She has served as a consultant and lead researcher for OSCE, ODIHR, UN Women, UNDP, and the Council of Europe. Her contributions have been recognized nationally and internationally, including the OSCE "Person of the Year" award and the "Anđelka Milić" Award for feminist activism and social change.

Introductory Reflection: Shahla Ismayil, Chair of Women's Association for Rational Development, Azerbaijan

Shahla Ismayil has over 25 years of experience advancing gender equality and women's rights. She chairs the Women's Association for Rational Development (WARD). She directs "Gender Port," Azerbaijan's first gender-oriented think tank. Since 2020, she has served as the elected country facilitator for the Azerbaijan National Platform of the EaP Civil Society Forum. Shahla is a founding member of the WPS Advisory Council and participates in dialogue platforms for peace in the South Caucasus.

She has led over 130 projects and authored more than 170 publications on human rights, gender, and civil society. Shahla developed formal versions of Azerbaijan's NAP 1325 and is a certified international expert in Human and Institutional Capacity Development, advocacy, and coaching. Her awards include the Bob Hepple Equality Award (2018), France's National Order of Merit (2022), and Azerbaijan's National Medal "Progress" (2023).

Atifete Jahjaga, Founder of Jahjaga Foundation, president of Kosovo ¹ (2011 - 2016)

Atifete Jahjaga was the first woman to serve as president of Kosovo, from 2011 to 2016. A staunch advocate for women's rights, she works to empower women and support survivors of conflict-related sexual violence. During her mandate, with a Presidential Decree, President Jahjaga established the National Council for the survivors of sexual violence during the war, which paved the way to the creation of legal infrastructure for survivors' rights and mobilized public support for their inclusion in peace processes. In 2018, she founded the Jahjaga Foundation, focusing on youth and women's empowerment to drive social change.

H.E. Fatmir Gjeka, Minister of Human and Minority Rights of Montenegro

Fatmir Gjeka (Bar, Montenegro, 1975) graduated from the Faculty of Economics at the "Luigj Gurakuqi" University in Shkodër in 1997 and completed postgraduate studies in entrepreneurial economics at the University of Montenegro (2005–2007).

From 2002 to 2011, he served as Secretary for Budget and Finance in the Municipality of Ulcinj, before becoming Director of the Public Enterprise in Ulcinj in 2011. That same year, he was elected President of the Democratic Party.

Elected as a Member of Parliament in the 2012 elections through the Albanian Coalition, he served on the Committee on European Integration and the Anti-Corruption Committee and chaired the Parliamentary Club of Albanian Parties, the Croatian Civic Initiative, and the Liberal Party.

Gjeka was elected Mayor of Ulcinj in 2014, serving until 2016. In 2018, he became President of the Ulcinj Tourism Organization. He returned to Parliament in 2020, representing the Albanian Coalition "Unanimously." Since April 2022, he has served as Minister of Human and Minority Rights of Montenegro, where he continues to promote equality, minority rights, and social inclusion.

Munira Subašić, President of Association "Movement of Mothers of Srebrenica and Žepa Enclaves", Bosnia and Herzegovina

Munira Subašić was born in 1948 in Stjenica near Rogatica. From 1967 to 1989, she lived with her husband, Hilmo, in Srebrenica, where she gave birth to two sons. From 1989 until the beginning of the war, she lived with her family in Vlasenica, and then returned with her family to Srebrenica, where they remained until July 1995. She survived the genocide in which 22 members of her immediate family were killed, including her husband, Hilmo, and her younger son, Nermin, who was just under 20 years old when he was killed in July 1995. She is the recipient of several acknowledgments and awards: "Victor Gollanz" – German Society for Threatened Peoples, the Golden Charter of Peace "Linus Pauling" – International League of Humanists, the "Women-Heroes of the Century" award from the Istanbul municipality of Bayrampaşa. She is the recipient of the Human Rights Award from the Spanish Bar Association. She is the founder and president of the Association "Movement of Mothers of Srebrenica and Žepa Enclaves".

Khrystyna Kit, Chair of Ukrainian women lawyers association "JurFem"

Khrystyna Kit is the coordinator of the expert group on conflict-related sexual violence at the Prosecutor General's Office of Ukraine and co-chair of the sub-pillar group "Access to Justice and Responsibility" within the Inter-Agency Working Group on Combating Sexual Violence Related to Russia's Armed Aggression against Ukraine and Assistance to Survivors. For over fifteen years, Khrystyna has been engaged in women's rights advocacy. In 2017, she co-initiated and co-founded the Ukrainian Women Lawyers Association "JurFem". Her work focuses on the challenges women face in accessing justice and legal protection, identifying legislative gaps, and addressing discriminatory gender-based practices. She is actively involved in developing and implementing legislation and public policies, training for social workers, police, judges, and lawyers on women's rights and gender-based violence, and conducting monitoring and research in this field.

Khrystyna also leads strategic litigation and legal training efforts for attorneys, prosecutors, investigators, and judges. Her work emphasizes a survivor-centered approach in cases of violence against women, applying the European Convention on Human Rights, CEDAW, and other European standards in court and investigative practice.

Samra Filipović-Hadžabdić is the Director of the Agency for Gender Equality of Bosnia and Herzegovina, within the Ministry for Human Rights and Refugees of BiH. In this capacity, she plays a central role in developing national strategies to mainstream gender equality across all government sectors.

Her leadership has been key to the adoption and implementation of major policy frameworks, including the fourth generation of the Gender Action Plan of BiH, the Action Plan for the implementation of UN Security Council Resolution 1325 on Women, Peace, and Security, and the Framework Strategy for the Implementation of the Istanbul Convention in Bosnia and Herzegovina.

She has led the drafting process of the Law on Gender Equality in BiH and has been instrumental in establishing gender institutional mechanisms since the early 2000s. She also initiated the development of Gender Master Studies programs in the country.

Recognized internationally for her expertise, she has served as an expert for the Council of Europe and the United Nations. Notably, she was a member of the Ad Hoc Committee responsible for drafting the Istanbul Convention. She regularly represents Bosnia and Herzegovina at UN sessions and leads national delegations in dialogues with UN treaty bodies.

Sanam Naraghi Anderlini MBE joined the London School of Economics and Political Science as Director of the Centre for Women, Peace and Security in December 2019. Sanam is a globally recognised advocate in the field of women, peace and security, with 24 years' experience as a peace strategist working on conflicts, crises and violent extremism with a mix of civil society, governments and the UN. Sanam is the founder and CEO of the International Civil Society Action Network (ICAN) where she spearheads the Women's Alliance for Security Leadership (WASL) comprising independent women-led organisations active in 40 countries, preventing violence and promoting peace, rights and pluralism.

In 2000, she was a civil society leader and drafter of UN Security Council Resolution 1325 on women, peace and security and in 2011 she was the first Senior Expert on Gender and Inclusion on the UN's Mediation Standby Team, working on Somalia, Libya and Syria among other cases. Her current appointments include serving on the Steering Board of the UK's National Action Plan on Women Peace and Security, the Commonwealth's Panel of Experts on Countering Violent Extremism (CVE), UNDP's Civil Society Advisory Council and as adjunct professor at Columbia University. She was the 2014 recipient of the UN Association Perdita Huston Award for human rights and the 2016 Greeley Peace Scholar at the University of Massachusetts.

Most recently, he served as the Senior Women, Peace and Security Adviser at the Office of Global Women's Issues at the U.S. Department of State. He is currently Vice Chair of Inclusive Security, Senior Fellow at Our Secure Future, and Lead Associate at Gender Associations International.

He has authored key resources such as the Women Waging Peace curriculum and contributed to the development of training on Security Sector Reform and National Action Plans (NAPs). A globally recognized trainer, he has facilitated over 700 training sessions and developed academic courses on peacebuilding, gender, and advocacy at universities worldwide.

His core focus is on helping governments translate international WPS commitments into actionable national policies. He has worked with over 80 governments and facilitated WPS NAP Academies in collaboration with ASEAN, the African Union, OSCE, UNDP, and UN Women.
